INVITATION TO BID FOR THE PROVISION OF FOOD AND CATERING SERVICES FOR THE CONDUCT OF SEASON-LONG TRAINING OF TRAINERS ON VEGETABLE PRODUCTION ON MAY 2 TO OCTOBER 1, 2019 AT ATI-RTC MiMaRoPa, BARCENAGA, NAUJAN, ORIENTAL MINDORO

1. The **AGRICULTURAL TRAINING INSTITUTE- REGIONAL TRAINING CENTER MiMaRoPa** through the **2019 General Appropriations Act (GAA)** intends to apply the sum of **ONE MILLION THREE HUNDRED THIRTY EIGHT THOUSAND PESOS (PhP 1,338,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **PROVISION OF FOOD AND CATERING SERVICES FOR THE CONDUCT OF SEASON-LONG TRAINING OF TRAINERS ON VEGETABLE PRODUCTION**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **ATI- RTC MiMaRoPa** now invites bids for the **Provision of Food and Catering Services for the Conduct Season-Long Training of Trainers on Vegetable Production**. Delivery of the Goods is required from **MAY 2 to OCTOBER 1, 2019**. Bidders should have completed, within **last two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **ATI RTC MiMaRoPa BAC Secretariat** and inspect the Bidding Documents at the address given below during **9:00am to 4:00pm., Mondays to Fridays.**

5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 28 to March 21, 2019** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **THREE THOUSAND PESOS ONLY(PhP3,000.00)**.


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **ATI RTC MiMaRoPa** will hold a Pre-Bid Conference on **06 March 2019 (Wednesday), 10:00 a.m.** at **ATI-RTC MiMaRoPa Session Hall A, Barcenaga, Naujan, Oriental Mindoro**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **21 March 2019 (Thursday), 10:00 a.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **21 March 2019 (Thursday), 10:30 a.m.** at **ATI-RTC MiMaRoPa Session Hall A, Barcenaga, Naujan, Oriental Mindoro**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **ATI-RTC MiMaRoPa** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
