## **INVITATION TO BID FOR *Provision of Hotel Accommodation for the 15<sup>th</sup> National Rice Technology Forum***

1. The Agricultural Training Institute-Regional Training Center 1, through the **GENERAL APPROPRIATION ACT (GAA) for FY 2022** intends to apply the sum of **Two Million One Hundred Eleven Thousand Two Hundred Fifty Pesos Only (Php 2,111,250.00)**, being the ABC to payments under the contract for the **Provision of Hotel Accommodation for the 15<sup>th</sup> National Rice Technology Forum** with Project No. **2022-08-0173**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **ATI-RTC 1** now invites bids for the above Procurement Project. Provision of Services is required by the **dates to be stated in the contract**. Bidders should have completed, **within Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **ATI-RTC 1** and inspect the Bidding Documents at the address given below during **8:00AM- 5:00PM, Monday to Friday, before the opening of bids**.
5. A complete set of Bidding Documents may be acquired by interested Bidders **August 11, 2022 to August 30, 2022** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00)*. The Procuring Entity shall allow the bidder to **present its proof of payment for the fees in person, or through electronic means**.
6. The **ATI-RTC 1** will hold a Pre-Bid Conference<sup>1</sup> on **August 18, 2022/ 9:00 AM at ATI-RTC 1, 4H Hub Show Room, Tebag East, Sta. Barbara, Pangasinan** which shall be open to prospective bidders.
