INVITATION TO BID FOR *Procurement of T-shirts for the School on-the-Air on Smart Rice Agriculture (SOA-SRA)*

1. The Agricultural Training Institute-Regional Training Center 1, through the **GENERAL APPROPRIATION ACT (GAA) for FY 2022** intends to apply the sum of **Six Hundred Ninety Thousand Pesos Only (Php 690,000.00)**, **Procurement of T-shirts for the School on-the-Air on Smart Rice Agriculture (SOA-SRA)** with Project No. **2022-06-0122** being the ABC to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The **ATI-RTC 1** now invites bids for the above Procurement Project. Delivery of the Goods is required by the **dates to be stated in the contract**. Bidders should have completed, **within Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **ATI-RTC 1** and inspect the Bidding Documents at the address given below during **8:00AM- 5:00PM, Monday to Friday, before the opening of bids**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **June 8, 2022 to June 28, 2022** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (Php 1,000.00)*. The Procuring Entity shall allow the bidder to **present its proof of payment for the fees person**.
6. The **ATI-RTC 1** will hold a Pre-Bid Conference¹ on **June 15, 2022/ 9:00 AM** at **ATI-RTC 1 Small Hall, Tebag East, Sta. Barbara, Pangasinan** which shall be open to prospective bidders.
