INVITATION TO BID FOR *Provision of Materials and Tokens* for the School on-the-Air on Smart Rice Agriculture

1. The Agricultural Training Institute-Regional Training Center 1, through the GAA for FY 2021 intends to apply the sum of **One Million Two Hundred Fifty Two Thousand Sixty Pesos (1,252,060.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **2021-07-140**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **ATI-RTC 1** now invites bids for **Provision of Materials and Tokens for the School on-the-Air on Smart Rice Agriculture**. Delivery of the Goods is required *30 Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **ATI-RTC 1** and inspect the Bidding Documents at the address given below during **8:00 a.m. to 5:00 p.m.**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **July 19, 2021** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only (P5,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **ATI-RTC I** will hold a Pre-Bid Conference on **July 22, 2021 9:00am** at **ATI RTC 1, Tebag East, Sta. Barbara, Pangasinan** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **August 4, 2021 9:00am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
