INVITATION TO BID FOR *Procurement of Catering Services for the 5 batches of the Training of Trainers on High Quality Inbred Rice and Seeds, and Farm Mechanization*

1. The Agricultural Training Institute-Regional Training Center 1, through the **GENERAL APPROPRIATION ACT (GAA) for FY 2022** intends to apply the sum of **One Million Seven Hundred Thirty-Two Thousand Five Hundred Pesos (1,732,500.00)** being the ABC to payments under the contract for **2022-02-0008**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The ATI-RTC 1, through the GAA for FY 2022 intends to apply the sum of **One Million Seven Hundred Thirty-Two Thousand Five Hundred Pesos (1,732,500.00)**, Provision of Catering Services for the 5 batches of the Training of Trainers on High Quality Inbred Rice and Seeds, and Farm Mechanization on various dates to be conducted at ATI-RTC 1, Tebag East, Sta.Barbara, Pangasinan/2022-02-0008 being the ABC to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The ATI-RTC 1 now invites bids for the above Procurement Project. Delivery of the Goods and Services is required on the day the activities were scheduled. Bidders should have completed, **within Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **ATI-RTC 1** and inspect the Bidding Documents at the address given below during **8:00AM- 5:00PM, Monday to Friday, before the opening of bids**.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below **on or before March 14, 2022 at 9:00 AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **March 14, 2022/ 10:00 AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **ATI-RTC 1** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
