 payments under the contract for the Replacement of Worn-out and Dilapidated Downspouts, including Waterproofing
 of All Concrete Ledges, ATI-CO Main Building (Contract Ref. No. ITB-ATI-CO-2017-05). Bids received in excess of the
 ABC shall be automatically rejected at bid opening.
- 2. The ATI CENTRAL OFFICE now invites bids for the REPLACEMENT OF WORN OUT AND DILAPIDATED DOWNSPOUTS, INCLUDING WATERPROOFING OF ALL CONCRETE LEDGES OF ATI CENTRAL OFFICE MAIN BUILDING AT ELLIPTICAL ROAD, DILIMAN, QUEZON CITY. Completion of the Works is required two (2) months. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II: Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- Bids must be duly received by the BAC Secretariat at the address below on or before 05 June 2017, 2:00 p.m. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on 05 June 2017, 2:30 p.m. at the Serrano Hall, Basement, ATI Central Office, Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. The ATI reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
