Description

- 1. The AGRICULTURAL TRAINING INSTITUTE (ATI), through the 2017 GENERAL APPROPRIATIONS ACT (GAA) intends to apply the sum of THIRTY MILLION PESOS (PhP30,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the COMPLETION OF THIRD FLOOR OF THE RDEC BUILDING, ATI CENTRAL OFFICE (Contract Ref. No. ITB-ATI-CO-2017-04). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The ATI CENTRAL OFFICE now invites bids for the COMPLETION OF THIRD FLOOR OF THE RURAL DEVELOPMENT EDUCATION CENTER (RDEC) BUILDING LOCATED AT THE ATI CENTRAL OFFICE COMPOUND, DILIMAN, QUEZON CITY. Completion of the Works is required six (6) months. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II: Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The ATI-BAC will hold a Pre-Bid Conference on 22 May 2017, 10:00 a.m. at Serrano Hall, Basement, ATI Central Office, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 05 June 2017, 1:00 p.m. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18

Bid opening shall be on 05 June 2017, 1:30 p.m. at the Serrano Hall, Basement, ATI Central Office. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. The ATI reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
