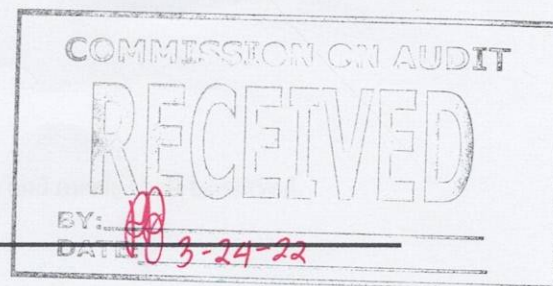

Contract Agreement Form



THIS AGREEMENT made on the 19th day of March 2022 between *AGRICULTURAL TRAINING INSTITUTE - REGIONAL TRAINING CENTER I* at Tebag East, Sta. Barbara, Pangasinan, Philippines hereinafter called "the Entity" of the one part and *EL JARDINE FOOD CATERING AND MANAGEMENT SERVICES* with business address at Libsong West, Lingayen, Pangasinan hereinafter called "the Supplier" of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., *Provision of Catering Services for the Five (5) batches of Training of Trainings on High Quality Inbred Rice and Seeds, and Farm Mechanization on various dates to be conducted at ATI-RTC 1, Tebag East, Sta. Barbara, Pangasinan* and has accepted a Bid for the provision of catering services in the sum of *One Million Seven Hundred Eleven Thousand Five Hundred Pesos (Php 1,711,500.00)* (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Performance Security; and
  - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. The Entity hereby covenants to pay the Supplier in accordance with the cost of the actual services and payment shall be made after the completion of each batch of the training.
6. In the event that the expected participants failed a hundred percent attendance as per reservation, the reserved food for the participants for the first day shall be paid in full and the payment for the succeeding days shall depend on the actual number of participants.


7. That the supplier shall observe the prescribed hour when snacks and meals shall be served.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




