**A RESOLUTION DECLARING RAMGO INTERNATIONAL CORPORATION AND MARABE ENTERPRISES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDERS FOR THE PROCUREMENT OF AGRICULTURAL SUPPLIES FOR LOT 1; AND LOTS 2 AND 3, RESPECTIVELY AND RECOMMENDING AWARD**

**WHEREAS**, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” Created the Bids and Awards Committee Secretariat (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

**WHEREAS**, Section 10, Rule IV of the IRR-A of the RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under the Rule XIV;

**WHEREAS**, the Procurement of Agricultural Supplies, not being an exemption, must necessarily pass through competitive bidding;

**WHEREAS**, The Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project in PhilGEPS website (PhilGEPS Ref. No. 7930365) and the ATI Website with **Approved Budget for the Contract of:**

**WHEREAS**, in response to the said posting, three (3) prospective bidders bought the bidding documents from the BAC Secretariat and thus submitted their bid proposals:

**WHEREAS**, during the Bid Opening held on September 13, 2021, it was found out that having complied with all the eligibility/technical and financial requirements, both bidders were rated as “**ELIGIBLE**” to participate in the bidding and thus rated as “**PASSED**”;

**WHEREAS**, the bid proposal submitted by the Bidder for each Lot (Lot 1; Lot 2 and 3) has been declared as **LOWEST CALCULATED BID for each lot. Hence**, the BAC Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation and verification of all the eligibility documents, technical and financial requirements/documents, including post-qualification documents as required by RA 9184 and its Implementing Rules and Regulations, and found it to be “**Responsive**” to the ATI’s requirements (see attached Bid Evaluation Report and Post Qualification Report of BAC TWG);

WHEREAS, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation and declared the two bidders, namely: (1) RAMGO INTERNATIONAL CORPORATION and (2) MARABE ENTERPRISES, as **LOWEST CALCULATED AND RESPONSIVE BIDDER** for LOT 1 and LOTS 2 and 3, respectively;

**NOW THEREFORE**, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

1. Declare (1) **RAMGO INTERNATIONAL CORPORATION** and (2) **MARABE ENTERPRISES**, as **LOWEST CALCULATED AND RESPONSIVE BIDDER** for LOT 1 and LOTS 2 and 3, respectively, for the Procurement of Agricultural Supplies (PhilGEPS Ref. No. 7930365);
2. Recommend for the approval and award of the said Contracts to **RAMGO INTERNATIONAL CORPORATION** for **LOT 1**, at its submitted bid proposal amounting to **FIVE HUNDRED NINETY-FOUR THOUSAND THREE HUNDRED THIRTY PESOS ONLY (PHP. 594,330.00)**; and **MARABE ENTERPRISES** for **LOTS 2 and 3**, at its submitted bid proposal amounting to **THREE MILLION THIRTY-FIVE THOUSAND FIVE HUNDRED TWENTY-SIX PESOS ONLY (PHP. 3,035,526.00)**; and
3. Recommend for Approval by the ATI OIC - Director IV the foregoing findings/recommendations.
