**A RESOLUTION DECLARING DEX INTERNATIONAL CO. AS THE LOWEST CALCULATED AND
RESPONSIVE BIDDER FOR THE CONSTRUCTION OF PASSENGER ELEVATOR ATI MAIN
BLDG.**

BAC Resolution No. 04-01, s. 2021

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" Created the Bids and Awards Committee Secretariat (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, Section 10 Rule IV of the IRR-A of the RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under the Rule XIV;

WHEREAS, the Construction of Passenger Elevator, not being an exemption, must necessarily pass through competitive bidding;

WHEREAS, The Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with **Approved Contract amount of Php 7,890,000.00** in PhilGEPS website (ITB-ATI-CO -2021-02/PhilGEPS Ref. No. 7507479) and the ATI Website;

WHEREAS, in response to the said posting, two (2) prospective bidders bought the bidding documents from the BAC Secretariat and thus submitted their bid proposals - **(1) DEX INTERNATIONAL CO., AND FIRST R+J BUILDERS**;

WHEREAS, during the Bid Opening held on March 22, 2021, the two (2) bidders were able to comply with all the eligibility/technical and financial requirements and were rated as "eligible" to participate in the bidding and thus rated as "pass";

WHEREAS, the bid submitted by **DEX INTERNATIONAL CO.** has been declared as the **lowest bid**, the BAC Technical Working Group (TWG) for Infrastructure projects conducted a careful examination, validation and verification of all the eligibility documents, technical and financial requirements/documents, including post-qualification documents as required by RA 9184 and its IRR found it to be "**Responsive**" to the ATI's requirements (see attached Bid Evaluation Report and Post Qualification Report of BAC TWG);

WHEREAS, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation and declared **DEX INTERNATIONAL CO.** as the **LOWEST CALCULATED AND RESPONSIVE BIDDER**;


NOW THEREFORE, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

1. Declare **DEX INTERNATIONAL CO.**, as the Lowest Calculated and Responsive Bidder for the Construction of Passenger Elevator at ATI Main Building (ITB-ATI-CO -2021-02/PhilGEPS Ref. No. 7507479);
2. Recommend for the approval and award of the said Contract to **DEX INTERNATIONAL CO.**, at its submitted bid price amounting to **SEVEN MILLION ONE HUNDRED SEVENTY-EIGHT THOUSAND SIX HUNDRED FIFTY PESOS (PHP 7,178,650.00)**
3. Recommend for Approval by the ATI Director the foregoing findings/recommendations.


