- **WHEREAS**, Section 10, Rule IV of the IRR-A of the RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under the Rule XIV;
- **WHEREAS**, the Procurement of Agricultural Supplies for the Establishment of 13 Urban Agriculture Community Garden, not being an exemption, must necessarily pass through competitive bidding;
- WHEREAS, The Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project in PhilGEPS website (PhilGEPS Ref. No. 67644) and the ATI Website with Approved Budget for the Contract amounting to PhP 1,300,000.00;
- WHEREAS, in response to the said posting, only one (1) prospective bidder bought the bidding documents from the BAC Secretariat and thus submitted their bid proposal HARBEST AGRIBUSINESS CORPORATION;
- **WHEREAS**, during the Bid Opening held on November 24, 2020, it was found out that having complied with all the eligibility/technical and financial requirements, the lone bidder was rated as "**ELIGIBLE**" to participate in the bidding and thus rated as "**PASSED**";
