**A RESOLUTION RECOMMENDING APPROVAL OF REPEAT ORDER AND AWARD OF CONTRACT
FOR THE PROVISION OF CATERING SERVICES FOR THE PARTICIPANTS OF YOUNG FILIPINO
FARM LEADERS TRAINING PROGRAM IN JAPAN (YFFLTPJ) PRE-DEPARTURE ORIENTATION
COURSE**

Section 51 of the Revised IRR of RA 9184

BAC Resolution No. PAD-04-02, s. 2020

WHEREAS, as a general rule, all procurement shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any alternative method of procurement;

WHEREAS, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

WHEREAS, repeat order is a method of procurement of Goods from the previous winning bidder, whenever there is a need to replenish goods procured under a contract previously awarded through Competitive Bidding. Repeat orders shall be availed of only within six (6) months from the date of the Notice to Proceed arising from the original contract and shall not exceed twenty-five percent (25%) of the quantity of each item in the original contract;

WHEREAS, President Rodrigo Roa Duterte issued a Proclamation No. 22 Declaring a State of Public Health Emergency throughout the Philippines last March 8, 2020 to combat the threat posed by the rising cases of infection of COVID-19;

WHEREAS, ATI Central Office conducted a public bidding last January 2020 and awarded the contract to MP Evangelista Catering Services in the amount of PHP2,326,500.00 for the for the provision of the Catering Services for Young Filipino Farm Leaders Training Program in Japan (YFFLTPJ) Pre-departure Orientation Course;

WHEREAS, due the implementation of Enhanced Community Quarantine in Luzon and prohibition of international flights, the participants of the program are now on their extended stay at ATI Central Office waiting for the public health crisis to end for them to be able to travel to Japan or return to their respective home provinces;

WHEREAS, to support the daily meal requirements of the stranded YFFLTPJ participants, the end-user (Partnership Accreditation Division) prepared a Purchase Request amounting to Php. 216,000 citing the repeat order provision of the Revised IRR of RA 9184;

NOW THEREFORE, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, *hereby RESOLVE AS IT HEREBY RESOLVED* to:

- 1. Recommend to use the Repeat Order provision of RA 9814 for the procurement of additional meals for the Young Filipino Farm Leaders Training Program in Japan (YFFLTPJ) Pre-departure Orientation Course;**
- 2. Recommend the approval and award by the ATI Director of this Resolution and Purchase Order/Contract to M.P. Evangelista Catering Services amounting to Php. 216,000.00 for the provision of catering services for the participants of Young Filipino Farm Leaders Training Program in Japan (YFFLTPJ) Pre-departure Orientation Course.**
