**A RESOLUTION DECLARING RAMGO INTERNATIONAL CORPORATION AS THE SINGLE  
CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF AGRICULTURAL  
SUPPLIES FOR LOT 1 (SEEDS) AND RECOMMENDING AWARD**

BAC Resolution No. PAO-09-02, s. 2020

**WHEREAS**, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” Created the Bids and Awards Committee Secretariat (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

**WHEREAS**, Section 10, Rule IV of the IRR-A of the RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under the Rule XIV;

**WHEREAS**, the Procurement of Agricultural Supplies (Seeds), not being an exemption, must necessarily pass through competitive bidding;

**WHEREAS**, The Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project in PhilGEPS website (PhilGEPS Ref. No. 7115932) and the ATI Website with **Approved Budget for the Contract amounting to Php 6,159,150.00**;

**WHEREAS**, in response to the said posting, only one (1) prospective bidder bought the bidding documents from the BAC Secretariat and thus submitted their bid proposal - **RAMGO INTERNATIONAL CORPORATION**;

**WHEREAS**, during the Bid Opening held on August 10, 2020, it was found out that having complied with all the eligibility/technical and financial requirements, the lone bidder was rated as “**ELIGIBLE**” to participate in the bidding and thus rated as “**PASSED**”;

**WHEREAS**, the bid proposal submitted by **the Bidder has been declared as SINGLE CALCULATED BID. Hence**, the BAC Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation and verification of all the eligibility documents, technical and financial requirements/documents, including post-qualification documents as required by RA 9184 and its Implementing Rules and Regulations, and found it to be “**Responsive**” to the ATI’s requirements (see attached Bid Evaluation Report and Post Qualification Report of BAC TWG);

**WHEREAS**, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG’s recommendation and declared RAMGO INTERNATIONAL CORPORATION, as **SINGLE CALCULATED AND RESPONSIVE BIDDER**;

**NOW THEREFORE**, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, *hereby RESOLVE AS IT HEREBY RESOLVED* to:

1. Declare **RAMGO INTERNATIONAL CORPORATION**, as **SINGLE CALCULATED AND RESPONSIVE BIDDER**, for the Procurement of Agricultural Supplies – Seeds (LOT 1) (PhilGEPS Ref. No. 7115932);
2. Recommend for the approval and award of the said Contract to **RAMGO INTERNATIONAL CORPORATION**, at its submitted bid proposal amounting to **FOUR MILLION TWO HUNDRED FORTY-FIVE THOUSAND TWENTY-TWO PESOS AND 23/100 (Php 4,245,022.23)**; and

3. Recommend for Approval by the ATI Director the foregoing findings/recommendations.
