**A RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING ALTERNATIVE METHOD OF
PROCUREMENT – NEGOTIATED PROCUREMENT – EMERGENCY CASES**

Section 53.2 and Annex “H” D-2 of 2016 Revised IRR of RA 9184

BAC Resolution No. AFD-07-01, s. 2021

WHEREAS, as a general rule, all procurement shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any alternative method of procurement;

WHEREAS, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

WHEREAS, under Section 52.3 of the RA 9184 and its Revised IRR, Negotiated Procurement on Emergency Cases is allowed in case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities. In the case of Infrastructure Projects, the Procuring Entity has the option to undertake the project through negotiated procurement or by administration or, in high security risk areas, through the AFP;

WHEREAS, President Rodrigo Roa Duterte issued a Proclamation No. 22 Declaring a State of Public Health Emergency throughout the Philippines last March 8, 2020 to combat the threat posed by the rising cases of infection of COVID-19;

WHEREAS, Civil Service Commission Memorandum Circular No. 10 s. 2020 No. 4-a indicates support mechanisms must be ensured such as health and psychological interventions;

WHEREAS, the Secretary William D. Dar of the Department of Agriculture issued a Memorandum dated April 5, 2021 to Agricultural Training Institute(ATI) instructing ATI to designate an area to serve as an isolation facility for DA COVID infected employees;

WHEREAS, the Secretary also verbally instructed the ATI Director to provide meals for the personnel of the Department of Agriculture under isolation/quarantine;

WHEREAS, a Purchase Request No. **ADMIN FUND 2021-06-63B** with an approved budget for contract of **Php 304,350.00** was approved by ATI Director for the purpose of **Meals and Snacks to be served During Home Quarantine of DA Personnel last April 08 to May 08, 2021.**

WHEREAS, ATI-BAC upon preparation of the appropriate documents, may directly negotiate with a supplier, contractor, consultant, with technical legal and financial capability to deliver the goods, execute the works and perform the services to address the emergency. Upon confirmation and ascertainment of such capability to address the emergency, the HOPE, upon recommendation of the BAC, shall immediately award the contract to the Supplier, Contractor or Consultant;

NOW THEREFORE, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

- 1. Recommend Alternative Method of Procurement through Negotiated Procurement-Emergency Cases as provided in Sec. 53.2 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services/infrastructure projects/consulting services;**
- 2. Recommend the approval and award by the ATI Director of this Resolution and Purchase Order/Contract to THEA's EVENT CATERING SERVICES with contract amount of Php 304,350.00**
