EXCLUSION FROM COMPETITIVE PUBLIC BIDDING OF THE CONTRACT FOR THE PROVISION OF VENUE AND FOOD FOR THE CONDUCT OF 2018 RICE ACHIEVERS AWARDING CEREMONY ON MAY 31, 2019 AND ADOPT NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE) AS THE ALTERNATIVE MODE OF PROCUREMENT AND RECOMMENDING APROVAL

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the bids and award committee (BAC) to ensure among others that the procuring entity abides by the standards set forth by the said Act;

WHEREAS, pursuant to section 10 Rule IV of the said Act, all procurements shall be done through competitive bidding, except as provided in Rule XVI thereof;

WHEREAS, under the section 48, Rule XVI of the IRR of RA 9184, it was stipulated that in order to promote economy and efficiency and to ensure that the most advantageous price for the government is attained, the Procuring Entity may resort to alternative methods of procurement;

WHEREAS, the partnerships and Accreditation Division (PAD) prepared Purchase Request No. PAD (RICE) FUND 2019-01-16 for the venue and food for the conduct of the 2018 Rice Achievers Awarding Ceremony;

WHEREAS, the ATI\_BAC Secretariat posted the request for the quotation for the aforementioned project in the PhilGEPS website through (PhilGEPS Ref. No. 6005821) and ATI website;

WHEREAS, in response to the said posting, only the Philippine International Convention Center (PICC) submitted a quotation specifically for the venue requirements. Upon evaluation PICC conforms to the requirements of the Agricultural Training Institute, amounting to **TWO MILLION TEN THOUSAND PESOS** (PHP 2,010,000.00) taking into consideration the location of the venue of the 2018 RAA Ceremony (PICC) to the hotel where the awardees and the RAA working committees shall be billeted and the reasonableness of the price quotation;

WHEREAS, Annex H, Negotiated Procurement (Lease of Real Property and Venue) of the revised IRR of RA 9184, provides that it is preferred that government agencies lease publicly owned real property or venue that complies with the requirements of the procuring Entity, it may enter into a contract of the lease with the government-agency owner;

NOW THEREFORE, for and consideration of the foregoing, WE, the members of ATI-BAC, hereby recommend the following:

- 1. Adopt Negotiated Procurement (Lease of Real Property and Venue) as the alternative mode for the aforementioned procurement; and
- Declare the Philippine International Convention Center as the lessor with the Single Lowest Calculated and Responsive Quotation for the provision of the food and venue for the 2018 Rice Achievers Awarding Ceremony to be held on May 30, 2019;
