

## A RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING EMERGENCY PROCUREMENT UNDER **REPUBLIC ACT 11469 AND AWARD**

BAC Resolution No. PAD-06-03, s. 2020

WHEREAS, as a general rule, all procurement shall be done through competitive bidding except

whenever justified by the conditions in order to promote economy and efficiency, may resort to any alternative method of procurement;

WHEREAS, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE)

the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

WHEREAS, President Rodrigo Roa Duterte issued a Proclamation No. 22 Declaring a State of Public

Health Emergency throughout the Philippines last March 8, 2020 to combat the threat posed by the rising cases of infection of COVID-19;

WHEREAS, to ensure the availability of food for all affected sectors, under Guidelines for Emergency

Procurement under Republic Act No. 11469 or the Bayanihan to Heal as One Act, Procuring Entities are encouraged to directly

purchase agricultural products from local farmers or farmers' associations or cooperatives;

WHEREAS, in response to emergency and mitigate the impact of COVID-19 to farmers, the

Agricultural Training Institute, through its Director/Head of Procuring Entity had approved Purchase Request PAD FUND 202005-31A dtd. May 11, 18 and 26, 2020 for the procurement of Garden Soil, Carbonized Rice Hull, and Molasses with the approved budget for contract (ABC) amounting to Php 997,500.00 using the Guidelines for Emergency Procurement under Republic Act No. 11469 or the Bayanihan to Heal as One Ac and the General Memorandum Order No. 01 Guidelines on DA Procurement Process during the State of Calamity;

WHEREAS, the DA General Memorandum Order No. 01 re: Guidelines on DA Procurement Process

during the State of Calamity encourages PEs to directly purchase agricultural products from local farmers or farmers' associations or cooperatives to ensure availability of food for affected sectors;

WHEREAS, for farmers' associations and cooperatives if the Procuring Entity is already maintaining

a bidder's updated file of any of the following requirements, whether through the Philippine Government Electronic

Procurement System Certificate of Registration and Membership or its own records, shall not require its re-submission. Otherwise, PEs shall require copies of Mayor's or Business Permit. For projects with an ABC above PhP500,000.00: Income Tax Returns (Annual Income Tax Return of the preceding tax year) or Business Tax Returns (Value Added Tax or Percentage Tax Return covering the previous six months) and original copy Omnibus Sworn Statement;

WHEREAS, for direct negotiation with local farmers, the submission of any of the following at any time before award or after award but before payment shall be sufficient: a certification that the farmer is in the Registry System for Basic Sectors in Agriculture (RSBSA); RSBSA identification card; or Barangay Certification that the supplier is a bonafide

WHEREAS, in direct purchase from local farmers, the PEs shall be guided by the following in the negotiation of prices for agricultural products:

the average prevailing farmgate price for the province, if purchased directly from the farmers;

the market price, if purchased from farmers' association or cooperative; or

the recommended retail price by the local price coordinating council for commodities sold by capable farmers, and farmers' associations or cooperatives in their respective provinces, municipalities and cities.

WHEREAS, the Head of Procuring Entity, upon recommendation of the BAC or duly authorized End-

user unit or any other appropriate bureau, committee, support or procuring unit, shall immediately award the contract to a legally, technically, and financially capable supplier, distributor, manufacturer, contractor, or consultant.

NOW THEREFORE, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE AS IT HEREBY RESOLVED to:

- $Recommend\ the\ procurement\ of\ the\ above-cited\ goods\ through\ Alternative\ Method\ of\ Procurement\ under\ Negotiated$ Procurement-Emergency Cases as stated in RA 11469 (Bayanihan To Heal as One Act);
- Recommend the approval and award by the ATI Director of this Resolution and Purchase Order/Contract to the bonafide Supplier indicated in the Request for Quotation as attached.
