Contract Agreement SUPPLY AND DELIVERY OF BOOKPAPER AND VELLUM PAPER

THIS AGREEMENT made the ____ day of _____ 2019 between the **AGRICULTURAL TRAINING INSTITUTE** of the Philippines (hereinafter called 'the Entity" of the one part and the **ADVANCE PAPER CORPORATION**, with office address at 47 Jordan Valley Village, Baesa, Caloocan City, (hereinafter referred to as the SUPPLIER) of the other part;

 - (a) the SUPPLIER's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) Schedule of Requirements;
 - (c) Technical Specifications;
 - (d) General Conditions of Contract;
 - (e) Special Conditions of Contract;
 - (f) Performance Security; and
 - (g) ENTITY's Notice of Award
- 3. In consideration of the payments to be made by the ENTITY to the SUPPLIER as hereinafter mentioned, the SUPPLIER hereby covenants with the ENTITY to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The ENTITY hereby covenants to pay the SUPPLIER in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by this Contract.
