The **AGRICULTURAL TRAINING INSTITUTE (ATI)**, a government agency under the Department of Agriculture, with its principal office located at the ATI Building, Elliptical Road, Diliman, Quezon City, represented by its Director, DR. LUZ A. TAPOSOK, hereinafter referred to as the ENTITY;

-and-

The **FIRST R+J BUILDERS PHILS. CORPORATION**, a private construction company duly registered and existing in accordance with the laws of the Republic of the Philippines, with office address at Unit 307 Times Square Building, No. 57 Examiner Street corner Times Street, West Triangle, Quezon City, Metro Manila, represented by its General Manager, MR. REINATO M. BARCA, hereinafter referred to as CONTRACTOR.

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Contract: **REPLACEMENT OF WORN OUT AND DILAPIDATED DOWNSPOUTS INCLUDING WATERPROOFING OF ALL CONCRETE LEDGES, ATI CENTRAL OFFICE MAIN BUILDING** (Contract Ref. No. ITB-ATI-CO-2017-05), hereinafter called "the Works" and the ENTITY has accepted the Bid amounting to **THREE MILLION NINETY NINE THOUSAND THREE HUNDRED NINETY TWO PESOS AND 01/100 (P3,099,392.01)** for the execution and completion of such Works and the remedying of any therein, with a contract duration of **sixty (60) calendar days**.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

- (1) In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- (2) The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Drawings/Plans;
  - (c) Specifications;
  - (d) Invitation to Bid;
  - (e) Instructions to Bidders;
  - (f) Bid Data Sheet;
  - (g) Addenda and/or Supplemental/Bid Bulletin;
  - (h) Bid Form, including all the documents/statements contained in the Bidder's bid envelope, as annexes, and all other documents submitted, including corrections to the bid, resulting from the Procuring Entity's bid evaluation;
  - (i) Eligibility requirements, documents and/or statement;
  - (j) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's Conforme thereto; and
  - (l) Other contract documents that may be required by existing laws and/or the Entity.




- (3) In consideration of the payments to be made by the ENTITY to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the ENTITY to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- (4) The ENTITY hereby covenants to pay the CONTRACTOR in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract or such other as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.




