The **AGRICULTURAL TRAINING INSTITUTE (ATI)**, a government agency under the Department of Agriculture, with its principal office located at the ATI Building, Elliptical Road, Diliman, Quezon City represented by its Director, LUZ A. TAPOSOK, hereinafter referred to as the **ENTITY**.

The **TRENDS & TECHNOLOGIES, INC.**, a private company duly registered and existing in accordance with the laws of the Republic of the Philippines, with office address at 6/F Trafalgar Plaza, Makati City, Metro Manila, represented by its Senior Account Manager, REGINA V. SILVERIO, hereinafter referred to as the **SUPPLIER**.

WHEREAS, the ENTITY is desirous that the SUPPLIER execute the Contract: SUPPLY AND INSTALLATION OF STRUCTURED CABLING, COMPONENTS, SWITCHES, OUTDOOR FIBER CONNECTIVITY AND IP CCTV CAMERAS AT THE ATI CENTRAL OFFICE, hereinafter called as the "Works" and the ENTITY has accepted the Bid amounting to FIVE MILLION EIGHTY THREE THOUSAND PESOS (P5,083,000.00) for the execution and completion of such Works and the remedying of any therein, with a contract duration of sixty (60) calendar days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- (1) In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
 - The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notice of Award.
- (3) In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- (4) The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
