



CONTRACT AGREEMENT
FOR THE PREVENTIVE MAINTENANCE OF ELEVATOR
ASSIGNED TO RDEC

This Agreement made on the 01 day of March 2021 between:

The AGRICULTURAL TRAINING INSTITUTE, a government agency under the Department of Agriculture, with principal office located at ATI Building, Elliptical Road, Diliman Quezon City, represented by its Director, ALFREDO S. ATON, MPS-DM hereinafter referred to as the **ENTITY**;

- And -

The HYUNDAI ELEVATOR SERVICES PHILIPPINES, INC. with principal office at 81 Kapigilan cor. Bayani Sts., Brgy Doña Imelda, Quezon City represented by FREDRICK ANTHONY W. SAMALA, hereunder referred as the **SERVICE PROVIDER**

Whereas the ENTITY is desirous that the SERVICE PROVIDER execute the Contract Procurement of Preventive Maintenance of Elevator assigned to the RDEC, hereinafter called "the Service" and the ENTITY has accepted the Bid amounting to **FIFTY-EIGHT THOUSAND TWO HUNDRED PESOS (PHP 58, 200.00)** for the contract duration of twelve months (12) months from March, 2021 to February 2022.

Now this agreement witnesseth as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, as follows:
 - a. Service Provider's Bid;
 - b. Terms of Reference for Preventive Maintenance; and
 - c. Entity's Notice of Award and the Bidder's Conforme thereto
3. In consideration of the payments to be made by the Entity to the Service Provider, as hereinafter mentioned, the SERVICE PROVIDER hereby covenants with the ENTITY to provide the preventive maintenance of elevator and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The ENTITY hereby covenants to pay the SERVICE PROVIDER in consideration of the preventive maintenance of elevator and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by this Contract.
