## Description

1. The AGRICULTURAL TRAINING INSTITUTE (ATI), through the 2018 GENERAL APPROPRIATIONS ACT (GAA) intends to apply the sum of THREE MILLION SIX HUNDRED TWENTY-TWO THOUSAND EIGHT HUNDRED TWENTY-FIVE PESOS AND 61/100 (PHP 3,622,825.61) being the Approved Budget for the Contract (ABC) to payments under the contract for the PROCUREMENT OF SECURITY SERVICES. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The ATI now invites bid for the Provision of Security Services. Delivery of the Goods is required for one (1) year. Bidder should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the ATI-BAC Secretariat and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.

6. The ATI will hold a Pre-bid Conference on 1 August 2018 at 10:00 a.m. at the LeAD Center, Ground Floor, ATI Central Office, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before 13 August 2018 at 9:30 a.m. All Bids must be accompanied by a bid security in any of the applicable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on 13 August 2018 at 10:00 a.m. at the LeAD Center, Ground Floor, ATI Central Office. Bids will be opened in the presence of the bidder's representative who choose to attend at the address below. Late bids shall not be accepted.

8. The ATI reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
