WHEREAS, the Agricultural Training Institute Director/Head of Procuring Entity had approved Purchase Request (P.R.) No. <u>ISD FUND 2020-10-37A f</u>or <u>Meals and Snacks</u> to be <u>served for the 4<sup>th</sup> Quarter CY 2020 for Meetings</u> and other Activities of ATI Different Divisions and Offices with Approved Budget for the Contract (ABC) of P 180.000.00 in accordance to the End-users Project Procurement Management Plan (PPMP);
