EXCLUSION FROM COMPETITIVE BIDDING OF THE CONTRACT FOR THE PROCUREMENT OF OKI PRINTER CONSUMABLES FOR PRINTING AND REPRODUCTION OF CORPORATE AND TECHNO-BASED INFO MATERIALS AND ADOPT DIRECT CONTRACTING AS ALTERNATIVE MODE OF PROCUREMENT

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, Section 10 Rule IV of the IRR-A of RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XVI;

WHEREAS, under Section 48, Rule XVI of the said Act, it was stipulated that in order to promote economy and efficiency and to ensure that the most advantageous price for the Government if attained, the Procuring Entity may resort to alternative mode of procurement;

WHEREAS, the ATI-Information Services Division (ATI-ISD) prepared Purchase Request no. ISD Fund 2019-01-10 for the procurement of OKI ES8473 and C9650 Toners, Drums, Transfer Belt and Fuser Unit for the printing and reproduction of Corporate and Techno-based Info Materials from January to June 2019;

WHEREAS, in response to the said Purchase Request, the COPY DATA SYSTEMS CORPORATION submitted its quotation amounting to FIVE MILLION FIFTY-ONE THOUSAND THREE HUNDRED NINETY PESOS (PHP 5,051,390.00), together with its Certificate of Exclusive Distributorship for OKI Color/ Monochrome printers and multi-function printers, consumables and supplies for the Philippines;

WHEREAS, the Chief of ATI-ISD submitted the Certificate of Satisfactory Performance favoring the COPY DATA SYSTEMS CORPORATION for the quality of service and products delivered as well as being responsive to the printing needs of the Division in the previous years;

WHEREAS, under Section 50 of the revised IRR of RA 9184, the law states that Direct Contracting may be resorted to those sold by an exclusive dealer or manufacturer, which does not have sub-dealers selling at lower prices, and for which no suitable substitute can be obtained at more advantageous terms to the Government;

NOW THEREFORE, for and in consideration of the foregoing, WE, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- Exclude from competitive bidding the procurement of OKI Toners, Drums, Transfer Belts and Fuser Units and adopt Direct Contracting as the alternative mode of procurement;
- Recommend to award the contract to COPY DATA SYSTEMS CORPORATION for the
  aforementioned procurement being an exclusive dealer for OKI Color / monochrome
  printers and multi-function printers, consumables and supplies for the Philippine at
  its submitted price FIVE MILLION FIFTY-ONE THOUSAND, THREE HUNDRED
  NINETY PESOS (PHP 5,051,390.00);
