SUPPLEMENTAL/BID BULLETIN (ADDENDUM NO. 02)

Hence, the prospective bidder may submit bid proposal for multi-purpose vehicles or for mini-bus alone, or may submit bid proposals for both.

(2) For Bid Security, the prospective bidder has the option to submit a duly notarized Bid Securing Declaration or any other form of bid security below:
